Deuel County Commissioner Meeting

January 5, 2016

The Deuel County Commissioners met on the above date with the following officials present: Chairperson Steve Fischer, Commissioner William Klingman, Commissioner Jerry Radke, County Attorney Joel Jay and County Clerk Polly Olson. The meeting, notice of which was published in the Chappell Register as according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. The agenda was approved upon motion of Commissioner Fischer, second of Commissioner Klingman. The meeting, notice of which was published in the Chappell Register as according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. The agenda was approved upon motion of Commissioner Klingman, second of Commissioner Fischer. Radke, absent, Fischer, aye, Klingman, aye. The minutes of the December 15, 2015 meeting were approved upon motion of Commissioner Fischer, second of Commissioner Klingman. Radke, absent, Fischer, aye, Klingman, aye.

County Highway Supt. Clint Bailey, Road foremen Mark Heidemann, Matt Bartels and office administrator Jennifer Velasco met with the Board to discuss the operations of the highway department. The first topic was the current gravel contracts. Upon motion of Commissioner Fischer, second of Commissioner Klingman, the gravel contract will be at .75 cents per yard. Radke, absent, Fischer, aye, Klingman, aye. Upon motion of Commissioner Klingman, second of Commissioner Fischer, the County will update the ten year Comprehensive Plan in the amount of \$15,000.00. Hannah Keelan will provide the services for the project. Radke, absent, Klingman, aye, Fischer, aye.

Custodian Jim Hinnegan met with the board to discuss the removal of the registers in the courthouse. The Commissioners feel that the energy efficiency project will be defeated if space heaters are continued to be used. It is their goal to ensure that each office is comfortable and the energy is used efficiently.

County Clerk, Clerk of the District Court presented a report of fees collected for the month of December 2015 in the amount of \$4,023.45. This report was reviewed and accepted for filing.


Discussion was held pertaining to use of the Courthouse annex for organizations. It was decided that organizations can use the facility if prior approval has been obtained from the County Board. One of the stipulations is that a county employee must be present for this purpose. County Attorney Joel Jay will prepare an agreement/application for use.

Revisions to the Deuel County Handbook were discussed. It was moved by Commissioner Fischer, second of Commissioner Klingman, to clarify the vacation time in the Deuel County Handbook. Going forward, the vacation time is a benefit to be used. The schedule will remain the same, with allowance of 5 days of unused to be carried over, but no more. It will not be a policy of the County to pay any unused vacation time. There will be no pay in lieu of vacation time. Clarification is also made regarding to exempt/nonexempt employees. A motion was made by Fischer, second of Klingman to approve the revisions to the Deuel County Handbook. Radke, absent, Fischer, aye, Klingman, aye.

Sheriff DeCoste presented a report of activities within his office. He presented a report of fees collected for the month of December, 2015 in the amount of \$88.55. This report was reviewed and accepted for filing. He also presented Three Distress Warrants totaling in \$681.67, which includes interest collected in the amount of \$15.14.

County Treasurer Bernie Littlejohn presented the 6 month report of fund balances as held in her office. This report was reviewed and accepted for filing.

Deuel/Garden County Extension Educator Sarah Paisley and Cheyenne County Extension Educator Karen DeBoer met with the board to discuss the activities within the Deuel/Garden Extension Office. An ad will be placed to find a temporary employee to cover the office in the absence of the current office assistance. It was reported that there is a vacancy on the Deuel/Garden Extension board. This vacancy will be filled at the February 2 meeting, upon recommendation of Extension Educator Paisley.

Noxious Weed Supt. Cris Burkes reported on activities within the Noxious Weed Department.



Discussion was held pertaining to the placement of the "Welcome to Chappell" on the county owned property. Motion was made by Commissioner Fischer, second of Commissioner Klingman, to approve the placement of said sign on county owned property. Rake, aye, Fischer, aye, Klingman, aye. A commercial sign lease agreement has already been in place for this signage on February 2, 2009. The terms of the lease were 10 years and automatically renewable for 10 year periods.

Lee Greene of Green Geo Innovations arrived to discuss the final billing. Clarification of the "change" order was discussed. One of the discrepancies has to do with the day charges. The County board agreed to pay the additional amount to allow Mr. Greene to contract with another company to mill the areas on CR 167 (wheatland) and the amount of \$20,000.00 for the golf course road. The additional day charges were not approved. Mr. Greene brought the receipts for the clay and he provided information for the costs of the additional days for the project. There was a disagreement over the additional days in the amount of \$6,500.00 per day. Mr. Greene had discussed the overage and why it was so much. The board will pay the invoices for the clay, the milling and the golf course road. Mr. Greene did not have any documentation to support his additional \$167,186.00. 





Deuel County Commissioner Meeting

September 6, 2016

The Deuel County Commissioners met on the above date with the following officials present: Chairperson Steve Fischer, Commissioner William Klingman, Commissioner Jerry Radke, County Attorney Joel Jay and County Clerk Polly Olson. The meeting, notice of which was published in the Chappell Register as according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. The agenda was approved upon motion of Commissioner Klingman, second of Commissioner Radke. Fischer, aye, Klingman, aye, Radke, aye. The minutes of the August 16, 2016 meeting were approved upon motion of Commissioner Radke, second of Commissioner Klingman. Fischer, aye, Radke, aye, Klingman, aye.

County Highway Supt. Clint Bailey met with the board to discuss the operations of the highway dept. Discussion was held regarding the additional claims from Greene Geo Innovations. Mr. Greene explained the additional expenses. The differences in the bid versus the actual charges included delays, due to the conditions of the base of the road, the need for more clay, the additional depth of the asphalt, the lack of equipment that could mill the deeper asphalt. A change order was approved by the board in the amount of \$70,000.00 for additional clay after a special meeting held in July. There appeared to be miscommunication in the charges for the clay and additional day hours at \$6,500.00. The day hours were not approved as Mr. Greene could not actually anticipate the additional days it would take to finish the project. The final adjusted billing from Mr. Green was in the amount of \$136,500.00 for the additional 21 days of reclaimer and \$28,686.00 for equipment worn out in the process, (\$165,186.00 total), he indicated that this was due to the fact that the road was in worse shape than he had anticipated. The board indicated that they understood his explanation but were not willing to pay the full amount as the soil samples Mr. Greene took should have given him an idea of what he would be working with. The board offered \$68,250.00 to finalize the project costs. Mr. Greene countered with \$85,000.00 and the county would pay half of the costs associated with the repairs to the approach of the golf course road off of US Hwy 385. An offer of \$80,000.00 was countered by Commissioner Klingman with the same stipulation regarding the repairs to the golf course approach. Motion was made by Commissioner Radke to approve \$80,000.00 as a settlement, motion died for lack of second. The board tabled the subject to allow other agenda items to be addressed. This item will be readdressed prior to adjourning today.

Former members of the Nursing Home Board, Kelle Brott and Barbara Kepler reported on the funds left over from the sale of the MMCC, which are in holding by J. Leef, at the request of Auditor Donald Wilson. County Attorney Joel Jay will confer with legal representation of the nursing home board to discuss the dissolution of the board and action to finalization distribution.


A budget workshop was conducted each fund was reviewed with budget consultant Pete Peterson via telephone.

The purpose of the funds is to support the Diversion/Truancy Coordinator position servicing the Youth Diversion Program in Deuel County.


Correspondence was received in a form of a fax from Terry Jessen. He requested from the Commissioners and the Treasurer that the County offer three separate tax bills for each parcel, (one for E.S.U 13, one for W.N.C.C. and one for the County), to allow the taxpayer an option to protest a levy. County Treasurer Bernie Littlejohn indicated that there is nothing in statute that allows her to decide which taxes are paid on the tax statement and that there is not a tax program at this time that can provide the information for this type of request. The time involved to complete this type of project would require an additional employee for the office. Mr. Jessen requested a written response, the board will not respond in writing, the correspondence has been addressed during this meeting.

County Treasurer Bernie Littlejohn presented a report of the Distress Warrants in and for Deuel County and reported that all Distress Warrants have been paid in full. This report was reviewed and accepted for filing.

Sheriff Scott DeCoste met with the board to discuss the operations of his department. He presented a report of fees in the amount of \$226.56 for the month of September, 2016. This report was reviewed and accepted for filing.

Lynn Arenson met with the Board to discuss the MASA Medical Transport Solutions, a membership available to the employees of Deuel County. This plan would cover all members of the household, the coverage area is nationwide and it includes ground or air medical transport. The cost would be \$9.00 per employee, and if the whole year is provided, a discount will be applied for a cost of \$99.00 per year. She discussed the differences between the plans available. Motion was made by Commissioner Klingman, second of Fischer to provide the MASA coverage this year at no cost to the employees.

Deuel County Fair board members Cori Koehler, Jeff Ortgies, Teri Doty and Jacob Shaw met with the board to discuss the use of the fair-ground facilities. Mr. Shaw is requesting permission to use the fair-grounds for a demolition derby in 2017. The Commissioners informed Mr. Shaw that the fair-board approved the rentals for the grounds. The members

indicated that an agreement will need to be signed. A revised agreement was presented to County Attorney Joel Jay for approval. It was reported that the current agreement had not been revised for quite some time. In the new format, there is now a deposit required to use the fairgrounds/buildings as well as an increase in the amount of rent. A stipulation has been put into place that specifically identifies what is required to receive the deposit refund.

The Board of Commissioners received a written request from Keegan Brott to be appointed on the Deuel County Fair board.
