The Deuel County Commissioners met on the above date with the following officials present: Chairperson Steve Fischer, Commissioner Jean Timm, Commissioner William Klingman, County Attorney Jonathan Stellar, County Assessor Michele Bartlett, County Sheriff Scott DeCoste, Sheriff's office administrator Leslie Snell, Sheriff Deputy Jim McCormick, Highway Superintendent Anthony Armer, Roads Superintendent Kelly Kopetzky, and Deputy County Clerk Tammy Sherman. The meeting, notice of which was published in the Chappell Register as according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. The agenda was approved upon motion of Commissioner Klingman, second of Commissioner Timm; Fischer, aye, Klingman, aye, Timm, aye. The minutes of the July 19, 2022 meeting were approved upon motion of Commissioner Timm, second Commissioner Klingman; Fischer, aye, Timm, aye, Klingman, aye.

Public comment, none.

Deputy County Clerk reported fees collected by the Clerk's office for the month of July 2022, in the amount of \$3,705.81. The report was reviewed and accepted for filing.

County Attorney Stellar advised the board that Chappell Livestock LLC has the sale barn leased until February of 2023. He will put Mr. Bailey in contact with them to see if they can make arrangements to lease him a pen for his mules.

Operations of the highway department were discussed. Highway Supt. Anthony Armer advised the grader is still in the shop. They are in the process of mowing the road ditches and they have been helping Dickinson Land Surveyors locate section stakes.

Highway Supt. Armer presented Resolution 2002-4 Deuel County Budget Document Resolution Authorizing the County Treasurer to Transfer Funds; regarding the extra funds needed for the Day Road Project in 2021. WHEREAS the Deuel County Commissioners have the authority to request the Officials of the County to perform statutory duties, ALSO, WHERE AS, the Deuel County Commissioners have the authority to distribute STP funds received from the State of Nebraska to qualifying County Road projects as stated in Neb. Rev. Stat. 39-1307. THEREFORE, the Deuel County Commissioners authorize County Treasurer Alicia Adams to make a transfer from the 34750 Highway Street Buyback Program (STP) funds to the Deuel County Roads General Funds in the amount of \$119,796.75. Passed and approved this 2nd day of August, 2022; upon motion by Commissioner Klingman, seconded by Commissioner Timm; Timm, aye, Klingman, aye, Fischer, aye.

Armer updated the board on the new computer support/cyber security company BYTES project. The state has completed the authorization necessary for Bytes to communicate with the state's system. Upon receiving complete state approval, BYTES will start the final phases of the project. Armer stated they may start this week, if all goes as planned. The Treasurer's office has unresolved issues with their computers and printer. These issues should be resolved with the approval of the state networking system. The annex will also be included in the project. The courthouse needs a larger switch than originally planned. The annex will use the smaller switch and the courthouse will get a larger one. The new phones were installed Thursday July 28th. The phones are working very well.

Budget workshop scheduled for the next Commissioners meeting; Tuesday August 16 with Rachel Smith.

A short discussion was held concerning the extra used office equipment stored at the annex. The worn-out, broken equipment valued under \$100 can be discarded.

Sheriff Scott DeCoste reported for the Sheriff's department. The office has been painted. The Day Road is still getting a lot of traffic. Timm asked if quotes could be obtained for an automatic speed control system.

Sherriff DeCoste addressed the board regarding the possibility of buying out the contract for a prospective deputy. The cost of the buyout is approximately \$7011.12. The individual would come as a graduate of the Police Academy. If the individual would leave within a three-year time frame the remaining buy-out would have to be paid to Deuel County. The buyout agreement is getting to be common place within the law enforcement community. It guarantees the individual will stay in the department for a period of time, not just getting the accreditations and leaving within six months. A motion by Commissioner Timm, seconded by Commissioner Klingman to approve the buyout of this prospective deputy; Timm, aye, Klingman, aye, Fischer aye.

At 9:05 a.m. a motion by Commissioner Fischer, second Commissioner Klingman to go into executive session to discuss a personnel issue: Commissioner Klingman, Commissioner Fischer, Commissioner Timm, County Attorney Stellar present; Fischer, aye, Timm, aye, Klingman, aye. At 9:15 a.m. Sherman was asked to join the meeting. At 9:19 a.m. a motion by Commissioner Fischer, second Commissioner Timm to resume regular session with no action taken; Timm aye, Fischer, aye, Klingman, aye.

Warrants in the amount of \$149,230.14 were approved upon motion of Commissioner Fischer, second of Commissioner Timm, (Payroll \$34,160.19 Claims \$115,069.95). The bill for the playground equipment at the fairgrounds in the amount of \$7500 will be paid at the August 16th meeting; Fischer, aye, Timm, aye, Klingman, aye.
